

EXPUNGEMENT INFORMATION SHEET

Juvenile records and reports may be expunged in accordance with the provisions of the Louisiana Children's Code, Articles 917 through 922. The Clerk's Office for Jefferson Parish Juvenile Court has a form available for this purpose.

This form is to be used only by:

A person 17 years of age or older (or their attorney) IF the person was not adjudicated a delinquent for the commission of murder, manslaughter, any sexual crime, kidnapping or armed robbery.

The person moving for expungement is responsible for obtaining all necessary information. **NO COURT PERSONNEL WILL OBTAIN THE INFORMATION FOR YOU.** If you need information from the court or from a law enforcement agency, you must file a Motion for Disclosure. A form Motion for Disclosure is available from the Clerk's Office.

This form must be completed and accurately filled out by the applicant before filing with the Clerk of Court. **SEE THE ATTACHED LIST OF AGENCIES FOR ASSISTANCE IN DETERMINING WHO TO ADD TO THE "PLEASE SERVE" AT THE END OF THE MOTION.**

This form must be either typed or clearly printed.

If the motion to expunge includes several different charges, one motion may be filed; **HOWEVER, A SEPARATE PAGE 2 MUST BE COMPLETED FOR EACH CHARGE LISTED.**

All persons desiring to expunge juvenile records are encouraged to retain counsel for this purpose. NO ONE AT JUVENILE COURT CAN GIVE LEGAL ADVICE.

All motions for expungement will be set for a contradictory hearing unless the mover submits written waivers from the District Attorney AND from each agency whose records are sought to be expunged.

Attached hereto is a form "Order for Expungement". This order is to be completed and presented at the hearing on the expungement. Once the court orders the expungement, the conduct and conditions expunged are considered non-existent and are to be treated as non-existent is anyone asks. Only when specifically provided by law and upon court order can the fact of adjudication or expungement be released.

IT IS ORDERED that the Clerk of Court destroy all records including but not limited to pleadings, exhibits, reports, minute entries, correspondence and all other documents. Any references, documents, recordings or materials that cannot be destroyed may be maintained, but under no circumstances may they be released. The court may maintain a confidential record of the fact of an adjudication, which may be released only upon written motion of a court exercising criminal jurisdiction over the mover herein and then only for purposes authorized by the Code of Criminal Procedure.

IT IS FURTHER ORDERED that all officials, agencies, institutions, boards, systems and law enforcement officers and their employees, agents, and consultants destroy all reports and records concerning the above described conduct or condition whether on microfilm, computer card or tape, or any other photographic, fingerprint or any other information of any and all kinds of descriptions. The custodian of reports and records of the agency or office may maintain a copy of this Order. However, the custodian shall not disclose the fact that such judgment is maintained or that the destroyed reports or records previously existed to anyone except upon written order of the court.

IT IS FURTHER ORDERED that any and all agencies and law enforcement offices herein served and having any records of the conduct or condition file a sworn affidavit with the Clerk of Court for Juvenile Court, to the effect that such records have been destroyed and that no notation or references have been retained in any central depository which will or might lead to the inference that any record was on file with any agency or law enforcement office, which affidavit shall be filed with the Clerk of Juvenile Court for the Parish of Jefferson within _____ days of service of this Order.
