INSTRUCTIONS FOR MARRIAGE WAIVER

1) Eligibility:

- a. You must be at least 16 years of age to apply for a marriage waiver.
- b. If you are 16 or 17 years old, you cannot marry an adult when the age difference between you is three years or greater.

2) Steps:

- a. Fill out the Application for Judicial Authorization for Marriage Waiver.
- b. Have your parents/parent having custody/legal custodian(s)/tutor(s) complete the Affidavit of Consent to Minor's Marriage in front of a notary and two witnesses.
- c. Bring the completed Application for Judicial Authorization for Marriage Waiver, Affidavit of Consent to Minor's Marriage and both parties' birth certificates to the Clerk of Court's Office and file them.
- d. Wait to receive your court date in the mail and appear at court with your prospective spouse on that date.
